- 5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 1:00 Pm 2079-12-08 at the office of Rainadevi Chhahara Rural Municipality, Chhahara Palpa. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 1,57,000.00 which shall be valid for 30 days beyond the validity period of the bid.
