The bids will be opened in the presence of Bidders' representatives who choose to attend at 1:00PM on 19<sup>th</sup> Ashoj 2077 at the office of Rainadevi Chhahara Rural Municipality, Chhahara Palpa. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid which shall be valid for 30 days beyond the validity period of the bid.
