- 7. Electronic bids must be submitted to the Office of Rural Municipal Executive, Chhahara Palpa through PPMO websitewww.bolpatra.gov.np/egpon or before 12:00 Hrs on 2076-05-27.
- 8. The bids will be opened in the presence of Bidders' representatives, who choose to attend at 13:00 Hrs on 2076-05-27 at the Office of Rural Municipal Executive, Chhahara Palpa. Bids must be valid for a period of 90 days after bid opening and must be accompanied by scanned copy of the bid security in pdf format which shall be valid for 30 days beyond the validity period of the bid.
- 9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
