3. Bidder who chooses to submit their bid electronically only, download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. 5. The bids will be opened in the presence of Bidders' representatives who choose to attend at **1:00 Pm 2079-11-12** at the office of ***Rainadevi Chhahara Rural Municipality, Chhahara Palpa***. Bids must be valid for a period of **90 days** from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. **1,29,000.00** which shall be valid for 30 days beyond the validity period of the bid.
